CHRISTUS St. John Hospital is a 178-bed full-service acute care hospital, located across from NASA-Johnson Space Center in Nassau Bay, Texas. We offer a wide range of comprehensive medical services including cardiology, sports medicine, intensive care, emergency medicine, diagnostic imaging, advanced laparoscopic surgical procedures, a dedicated oncology unit, concussion services and private birthing suites for expectant mothers.



Our cancer program is accredited by the American College of Surgeon's Commission on Cancer and we are partnered with MD Anderson Cancer Center to bring comprehensive cancer treatment to the Bay Area Houston.

Our **Concussion Center** provides evaluation and treatment for sports related concussion injuries to local athletes. The Concussion Center is not limited to sports related concussions, but also conducts neuropsychological evaluations on individuals affected by traumatic brain injury, stroke, brain tumor, epilepsy, movement disorders, dementia, central nervous disorders and those who have experienced changes in their cognitive function. A neuropsychological evaluation assesses cognitive and behavioral function.

St. John Laboratory is pleased to offer the community an experienced pathology team, highly skilled in the performance and interpretation of fine needle aspiration biopsy. This minimally invasive test is a powerful tool in the initial diagnosis of both superficial and deep organ-related mass lesions, and is a critical component of therapeutic decision-making in patients with both malignant and benign tumors.

CHRISTUS St. John is a nationally accredited **Cycle II Chest Pain Center**. This accreditation is given by the Society of Chest Pain Centers.

The 20,000-square-foot sports medicine and rehabilitation complex offers a full range of rehabilitative treatment, a fitness center and hand, pediatric and aquatic therapies. The **Sports Medicine** program also provides 11 local area high schools with athletic trainers.

CHRISTUS St. Catherine Hospital is a full-service hospital offering comprehensive medical and surgical care in cardiology, oncology, intensive care, emergency medicine, diagnostic imaging, obstetrics and gynecology, pediatrics, bariatrics, advanced laparoscopic procedures, cancer treatment, cardiovascular and vascular specialties. The 102-bed hospital has the only Comprehensive Heart Program in Katy, providing cardiovascular services ranging from diagnostic procedures to open heart surgery.

The hospital was granted the designation of an accredited **Chest Pain Center with PCI**, dedicated to assessing a patient's heart problem quickly and accurately through the critical early stages of an acute coronary event to the diagnosis and recommended treatment that could save lives.

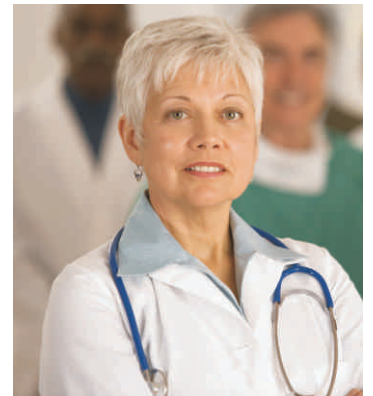


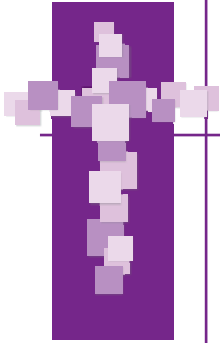

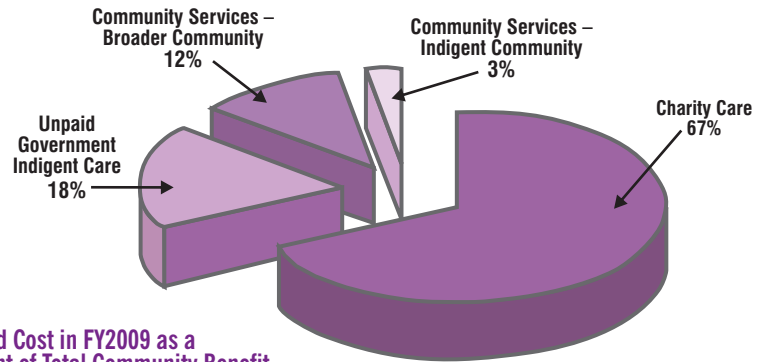
A Synopsis of Community Benefit in Fiscal Year 2009

CHRISTUS Health Gulf Coast, a region of the CHRISTUS Health system, continues our journey to excellence that began ten years ago by improving the health of the communities we serve. The region works closely with the communities to ensure identified needs are incorporated in the regional community-owned plan as well as the CHRISTUS Health system's strategic plan.

We actively fulfill our mission of extending the healing ministry of Jesus Christ by supporting a broad array of community-based services and programs that facilitate access to care with special attention given to the health status of the low income, uninsured and underinsured populations. This report of community benefit is only a snapshot of the support and value provided to the communities we serve.

CHRISTUS Health Gulf Coast follows the Catholic Health Association (CHA) and State of Texas guidelines for reporting community benefit.

Charity Care is defined as the unpaid cost of medical services provided to the uninsured and underinsured, including Medicaid. During fiscal year 2009, CHRISTUS Health Gulf Coast provided more than \$8.7 million in

Charity Care, which is 4.6 percent of the region's net patient revenue. Of this amount, **Unpaid Government Indigent Care** for the underserved, predominately Medicaid, comprises more than \$1.8 million of unpaid costs for fiscal year 2009, which is 1.0 percent of net patient revenue.

CHRISTUS Health Gulf Coast also contributed more than \$1.5 million in **Community Services** to the Gulf Coast community in fiscal year 2009. Thus, CHRISTUS Health Gulf Coast provided \$10.3 million in total community benefit, which is 5.4 percent of net patient revenue earned in fiscal year 2009. This equates to more than \$28,000 a day in community benefit.

CHRISTUS Health Gulf Coast reinvests all profits we earn back into the community through expanded health services, new technologies and better facilities.

In addition, cost of **Unpaid Government Sponsored Programs**, mostly Medicare is reported to the state of Texas following the state's Community Benefit reporting requirements. This year, that amount for CHRISTUS Health Gulf Coast was more than \$17.3 million, or 9.0 percent of the region's net patient revenue. In accordance with CHA Guidelines, CHRISTUS Health Gulf Coast does not include this amount in reports of community benefit provided to other agencies.
